APPROVAL OF MINUTES OF July 25, 2013

Motion by Mrs. Worth to approve the minutes of June 20, 2013: seconded by Mr. Davis; carried 6-0-1 with Mr. Alldredge abstaining due to his absence from the meeting.

Item 1. Show Cause Hearing for alleged Code of Laws Violation at Roger Dodger, LLC, dba "Lakeside Liquors", 5820 W. 44th Avenue, Wheat Ridge, Colorado, 80033

Mr. Roome introduced the item.

Roger Loecher, owner, and Scott Madsen, Manager appeared on behalf of Lakeside Liquor.

Opening Statements

Mr. Price stated that the owner, Mr. Loecher, is willing to stipulate that a violation of CRS Section 12-47-901(5)(a)(I) did occur.

Violation Phase

Motion by Mr. Miks that a violation of CRS Section 12-47-901(5)(a)(I) did occur; seconded by Mr. Davis; carried 7-0

On behalf of the City Officer Berkowitz recommended a 30 day suspension with 25 held in abeyance for 12 months, five days served.

Motion by Mr. Davis to direct the City Attorney to prepare findings for this meeting and further move to suspend the license of Roger Dodger, LLC, dba "Lakeside Liquors", 5800 W. 44th Avenue, Wheat Ridge, Colorado, 80033 for a period of 15 days,

Further moved that all 15 days held in abeyance for 12 months

Additionally, the owner will be required to have in place by September 1, 2013 a new point of sale cash register

Seconded by Mr. Alldredge; carried 7-0.
